



Wiring:

Identify the wire coming out of your Switch in the Diagram below looking at the right most plug view as follows:

From right to left

DIMMER-A (Allows symbol to light up with Dash): First 2

Note: Connect one end to ground and other end to Dimmer switch control from an adjacent switch.

Aux Lights-B: Remaining 2 wire (Use to provide +12V to a relay)

NOTE: PIAA 5298 Switch can be replaced with this switch. Cut the wires from the relay to the PIAA switch, about 3 inches away from the switch. Connect the wire from the high beam or +12V ignition switch to one end of the Aux Lights-B set of wire on your new OEM switch, and then connect the other end of the Aux Lights-B to the White with Red dots wire that was connected to the PIAA switch. Ground the White with Red dot wire. If you want your fog lights to come on with Hi and Low beam, connect the orange wire to the Green with Grey dot that powers your marker lights.

An LED can be added to show status of Aux light (Not Included unless purchased)

AFTERMARKET PRODUCTS AND YOUR VEHICLE'S WARRANTY

Many of our customers ask, "Will your product void my vehicle manufacturer's warranty?" While the answer is straightforward from a legal standpoint, we also want to educate our customers (and aftermarket Consumers) on some industry realities and offer some common sense precautions to minimize your risk.

Consumers of aftermarket products are protected by The Federal Magnusson-Moss Warranty Act. The Act states that if something breaks on your car and you take it in for warranty repair, the dealer must honor your warranty unless they can prove that whatever modifications you have added to your car actually caused the problem.

While as a consumer, you have strong legal protection with regards to your vehicle's warranty, there is also a practical reality that different automotive manufacturers and dealers have greatly varying views on aftermarket products, in particular those that produce horsepower, such as performance enhancement chips, modified intake manifolds, or aftermarket exhaust systems. There are dealers and manufacturers out there that will use the presence of a horsepower upgrade to void your vehicle's warranty. They will do this regardless of whose product you are using. Any aftermarket company that does not acknowledge this is misleading you.

The bottom line is that while the law protects the consumer and provides for enforcement of the warranty, it is very difficult for most people to hire an attorney and fight a voided warranty. Purefjrcruiser.com recommends that you always disconnect and remove your module and monitor when you take your vehicle to a dealer for warranty work in order not to interfere with Diagnostic equipment.
